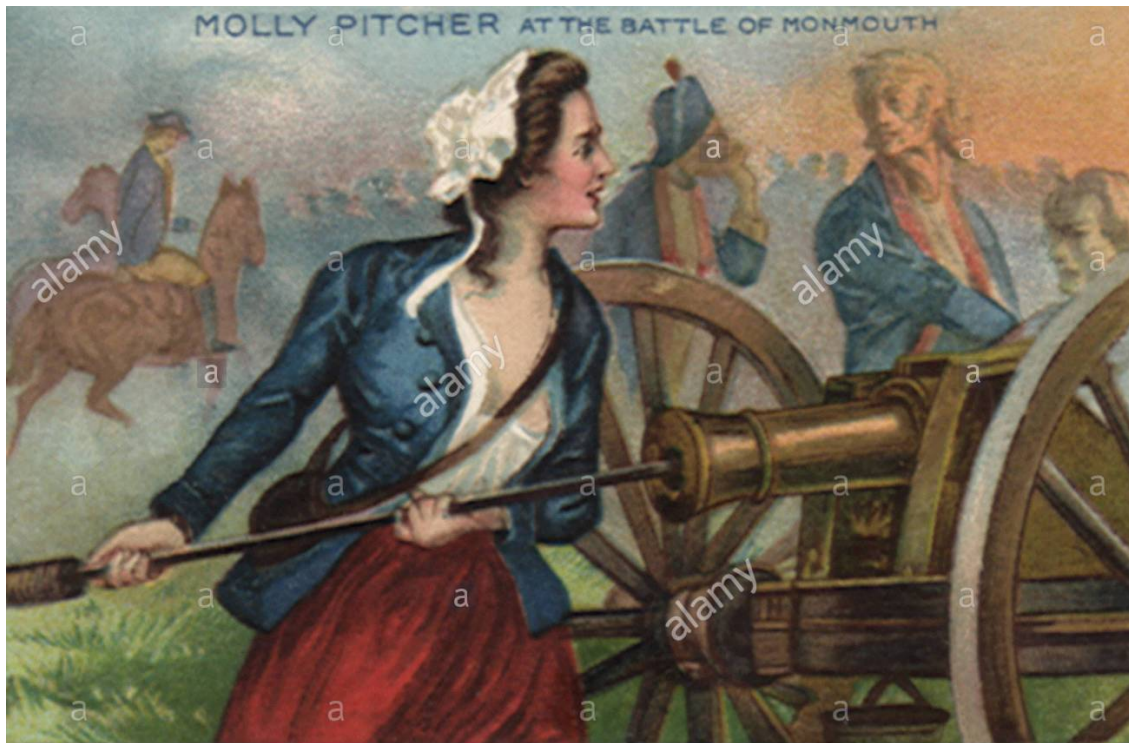

Yesterday, the Virginia Supreme Court threw out the suit against Governor Youngkin's mask mandate. This is in contrast to a lawsuit filed last week by several school districts in Virginia, the suit being upheld in the first round of arguments by an Arlington Circuit Court Judge. A 3rd suit will be heard later this week in Loudoun - filed by parents who are fed up with the Loudoun School Board for keeping their mask mandate in effect.

1st off, I want to thank you for your confidence in me these past 2 years. As most of you may be aware, I announced several weeks ago that I was running for re-election as your Congressional District Republican Party Chairman. We've done some amazing things together. We've increased vote turnout for Ben Cline from 58.7% in 2018 to 64.7% in 2020.

We swept Virginia in 2021, winning all 3 statewide offices, and have taken back the majority in the House of Delegates. But maybe most importantly was what we did at the local level.

We took back the School Board in Shenandoah County, we took back the School Board in Warren County. We took back the School Board in Roanoke County and Amherst County. We took back the School Board in Bedford County. We ran good candidates in pretty much every race from House of Delegates to School Board to the Board of Supervisors to Town elections.

With very few exceptions - everywhere the District GOP ran a candidate - we won.

Many of you have thanked me for "uniting the Party". I will tell you with a straight face that it is not my job, nor was it ever my job to unite the GOP. In the summer of 2020, the Washington Post mocked me for saying these words. But I stand by what I said in 2020, and will repeat them again.

The Party unites around good candidates. And those candidates need to articulate a positive conservative message. Where we ran good conservative candidates, we were united. Where we run candidates like Melanie Salins/Antoinette Funk (Warren County School Board) , Amber Morris (Front

unify. Where we don't nominate great conservative candidates - not so much.

With all that having been said, I filed my paperwork last week to run for a 2nd term as your Chairman. Last night was the filing deadline, and I am unopposed. So I will remain as your Chair for the next 2 years.

However there will be one contested seat - the Northern Regional Vice Chairman's spot. The Northern Region consists of: Frederick, Winchester, Clarke, Shenandoah, Warren, and Page. Randy Gilbert is the current Regional Vice Chair, and he's being opposed by Matt Leeds of Clarke County. Both Randy and Matt have unassailable conservative credentials - Randy being the leader on election integrity inside CD 6 and in Virginia. Matt being the former 10th Congressional District Chair.

I'd like to take this time to welcome Marshall Pattie, who filed and was unopposed for Central Regional Vice Chair, and Charlie Nave, who was unopposed for Southern Regional Vice Chair.

The convention will be on May 7 at the Augusta Expo Center. We're looking at having some great speakers - and continuing the fight to take back Virginia. Start time is 10 am.

I have enjoyed getting to know each of you these past several years, and am looking forward to many more years to come.
