Kyle Rittenhouse - Where Do We Go From Here?

As important as our victory on November 2 was to our future, so was the acquittal of Kyle Rittenhouse in Kenosha Wisconsin on Friday. This case has divided Americans along political lines in a way that has not been seen since the trial of John Brown back in 1859. And maybe more importantly, the Rittenhouse trial has forced alot of us to rethink our blind support of prosecutors.

For years most of us who supported law and order honestly believed that prosecutors were intellectually honest persons who were trying to do the best

rogue prosecutors. The fact that George Soros has been getting involved in District/Commonwealth Attorney races in the past few years have become very partisan in how they prosecute cases.

For years most prosecutors have been like Bethany Harrison of Lynchburg they show up to their offices, do their jobs - prosecute cases based on the law as they interpret the law, and we go from there. Bethany Harrison is a model of how a Commonwealth Attorney should handle their job. We must be sure to only nominate Commonwealth Attorneys and Constitutional Officers who understand what the parameters of their jobs are - and who do them to the best of their abilities. Commonwealth Attorneys like Bethany Harrison and Jared Moon of Rockbridge. Commissioners of the Revenue like Dan Cullers in Rockingham and Sabrina Von Schilling in Waynesboro. And Commissioner Rebecca Smith of Page County. Sheriff Chris Johnson of Waynesboro, Mike Miller of Bedford, and Tim Carter in Shenandoah. Clerk of the Court Chaz Haywood in Rockingham. The Constitutional Officers jobs may not be as sexy or garner the news that a City Councilor or House of Delegates Member may get - but their jobs are just as important, and maybe more so?

Remember that our justice system worked in the Rittenhouse trial because the people on the jury refused to be bullied by MSNBC and the radical leftists.
