Voting hours are Monday-Friday, 8:30 am - 4:30 pm. Saturday, June 10 voting from 9:00 am - 5:00 pm and June 17 voting hours 9:00 am - 5:00 pm.

Senate District 1 Republican Primary Early Voting In-Person:

North Main, Suite 103, Woodstock) beginning 45 days before Election Day (May 5) and ending the Saturday before Election Day (June 17). Voting hours are Monday-Friday, 8:30 am - 4:30 pm. Saturday, June 10 voting from 9:00 am - 5:00 pm and June 17 voting hours 9:00 am - 5:00 pm.

### To vote early in-person, do the following:

- You do not have to have a reason or fill out an application to vote early in person.
- At the registrar's office you must provide your name and address and show an acceptable form of ID.
- Accessible equipment and/or curbside voting is available upon request.

# IF YOU HAVE FAMILY MEMBERS THAT HAVE NOT REGISTERED TO VOTE (see below)

#### IF YOU NEED TO UPDATE AN EXISTING REGISTRATION (see below)

Deadline to register to vote, or update an existing registration, May 30, 2023 (Voters may register after this date, through Election Day, and vote using a provisional ballot).

Deadline to apply for a ballot to be mailed to you June 9, 2023. Your request must be received by your local voter registration office by 5:00 pm.

## Why Vote Early – Points to Consider

A growing chorus of Republicans are pleading with the GOP to rebuild its oncerobust early and mail voting programs, blaming the party's reluctance to embrace such efforts for a lackluster showing in the 2022 midterm elections.

But after the so-called red wave that Republicans had predicted ahead of the midterms failed to materialize, a growing number of influential GOP leaders and operatives say the party needs to more aggressively compete with Democrats when it comes to early and mail voting, fearing that a failure to do so could cost the GOP in future elections.

mail-in voting," said <u>Saul Anuzis</u>, a Republican strategist and former Michigan GOP chair. "I think there's a lot of tactical things that we have to take a look at," he added.

But some Republicans say that one of the biggest takeaways from the 2022 midterm elections is that the GOP should take advantage of expanded access to voting rather than fight it.

"You can bitch about the game as much as you want, but you gotta find a way to play the game, because the game's not going to change right now," said Ford O'Connell, a Republican strategist and former congressional candidate.

A survey from Harvard CAPS-Harris Poll highlighted Democrats' early and absentee voting advantage. Fifty-two percent of Democrats said they voted before Election Day compared to 45 percent of Republicans.

With the midterms now in the rearview mirror, even some Republicans who once criticized pre- Election Day voting have begun to take another look at the practice. Charlie Kirk, the conservative activist and commentator, tweeted that "one of the first lessons we have to take from the midterms is the power of early voting."

"Telling everyone to vote in-person on [Election Day] opens you to traffic jams and machine malfunctions," he tweeted. "If and when that happens, there's no rewinding time to change your strategy. You're at the mercy of the courts and voters' own schedules."

Nikki Haley, the former United Nations ambassador and South Carolina governor, said that Republicans were being outdone by Democrats when it comes to early and absentee voting and called on the GOP to "play the same game." "We were completely outplayed electorally. The Democrats did a full-court press to vote early. We sat on our hands. Early and absentee voting are here to stay. We need to play the same game and turn out the maximum number of voters. The left does it, and we don't." There's no indication that pre-Election Day voting is going away anytime soon. Since 2020, when the COVID-19 pandemic first pummeled the United States, a number of states have moved to expand early voting and no-excuse mail voting.

laws remain in place. House speaker Todd Gilbert, R-Shenandoah said, "We did not change those rules. But we certainly tried to abide by them, and had a lot more success than we ever could have imagined."

Virginia Republicans seemed to embrace early voting last year, telling supporters casting early ballots was the best way to ensure their vote would count.

### **Early Voting in Shenandoah County**

Voter turnout in Shenandoah County increased last year. While some precincts (Strasburg and Woodstock) were down, all the others saw an average increase of almost 5%.

Much of this increase is attributed to early voting. However an average of 32 people cast ballots during the first six days of early voting, this only represents 192 voters – not enough to sustain the overall voter increase.

The 45 days of early voting prior to election day gives people many opportunities to stop by the Voter Registration Office (600 North Main Street, #103) between the hours of 8:30 am – 4:30 pm to cast their safe, secure ballot.

We recommend you vote early, then help at the polls on election day – working inside or outside – your choice.
