<u>Eliminating an Unnecessary Federal Agency</u>

As one example of weaponized DC bureaucracy, the Federal Insurance Office's (FIO) costly regulations and oppressive federal oversight of each state's insurance markets are glaring examples of the federal government's excessive overreach. Worse, the Biden Administration issued a 2021 <u>Executive Order</u> that instructs the FIO to implement its Green New Deal agenda in the regulation of state insurance markets.

State laws protecting the availability of insurance for millions of Americans should be defended,

not used as a political football. My *Federal Insurance Office Elimination Act*, which I was proud to reintroduce this week, will defund and repeal the ever-expanding agency. This legislation is a good first step towards draining the D.C. swamp and returning necessary oversight back to the states.
