

1st off, Private 1st Class Thomas Cameron – 32nd Ohio Company A. PFC Cameron lost his life in defense of the USA on September 15 1862, at the Siege of Harpers Ferry in the Sharpsburg campaign (Antietam for those of you north of the Mason Dixon Line). PFC Cameron was killed by shrapnel/shell launched from Maryland Heights at Harpers Ferry. For those of you who are curious, Stonewall Jackson was the Confederate commander that day.

2nd, I want to honor my Confederate ancestor Robert Carlisle. Robert Carlisle was born in Rockbridge County in or around 1840, and moved to Alabama in the late 1850's. He joined the 9th Alabama Cavalry and fought with the 9th until being captured by Union forces outside Atlanta in 1864. General William Sherman commanded the Union forces. He was transferred to a prisoner of war camp in Indiana, where he later died from exposure sometime after the War ended.
